- 3. Any required Safety Codes permits (building, plumbing, electrical etc.) to be obtained prior to commencement of construction/installation.
- 4. Communication towers shall be located in a manner that minimizes the impact on the natural environment and residential communities while recognizing the unique location requirement for sitting communication towers.
- 5. All equipment shelters must meet the Villages setback distances to roads and property lines.
- 6. Appropriate access/egress shall be provided to the satisfaction of the development authority.
- 7. Where Transport Canada requires that a telecommunication tower to be lighted, there will be procedures that must be followed to minimize visual impacts, if applicable.
- 8. Alberta First call to be called before the sign is installed.
