2) Donna Rombough Development Proposal - was reviewed.

RESOLUTION: Councillor Lafontaine moved to accept in principal the proposal of Donna

Rombough with the following conditions:

1. Council will only approve the sale of 3 lots, 26, 27 & 28 in Fairway Place for the new 76 x 32 house and 20 x 40 foot garage.

2. All setbacks must be followed, as per land use bylaw.

3. A revised site plan as well as a development permit is also required for final approval. CARRIED.
