MINUTES OF A REGULAR MEETING OF THE COUNCIL OF THE VILLAGE OF VETERAN, IN THE PROVINCE OF ALBERTA, HELD TUESDAY, JANUARY 31, 2012, IN THE VILLAGE OFFICE.

ORDER: Mayor Gorcak called the meeting to order at 5:32 p.m.

PRESENT: Mayor Gorcak, Councillors Lafontaine and Allison, and C.A.O. Debbie Johnstone

AGENDA: Councillor Allison moved to adopt the agenda as presented. CARRIED.

MINUTES: Councillor Lafontaine moved that the minutes of the regular meeting of council held

on January 10^{th,} 2012, be approved as presented/amended. CARRIED.

The notes of the January 24^{th,} 2012 meeting with the Special Areas were accepted as

information.

OLD BUSINESS: 1) MSI Capital – hall kitchen renovation project does not qualify under MSI capital,

however, it would however qualify under MSI operating.

2) Cemetery – information was presented from other cemeteries.

BYLAWS: Cemetery Bylaw Review – changes will be made and brought forward to the next

meeting regarding burial lots.

NEW BUSINESS: 1) 2012 Projects – possible projects were presented. This will be brought forward to the

next meeting.

2) Rental of Arena – a request was received to rent the facility for June 1, 2012 by the

Consort 4-H Beef Club for their achievement day.

RESOLUTION Councillor Lafontaine moved to rent the arena to the Consort 4-H Beef Club on

June 1, 2012 free of charge for their achievement day, with the stipulation the arena

is cleaned after the event. ${\bf CARRIED.}$

3) Thornton Electric Hall Quote – was received regarding the generator upgrade for the

hall.

RESOLUTION Mayor Gorcak moved to approve the Thornton Electric quote of the generator

upgrade at the hall for \$1,950 as long as this quote included the receptacle outlet

outside the building on the east side. CARRIED.

4) Hall – Declared Value Endorsement – a signature is required on this form, which

was approved at the November 29th, 2011 meeting.

5) Insurance Premiums – have increased partially do the replacement cost values for

the office and shop and increase in arena and hall values.

DELEGATION 6:00 – Sam Vogel – NHCAL and Community Connection Centre – joined the meeting

to discuss happenings of the past year with the organization. As they receive funding from the Veteran FCSS, council wanted to reiterate the need for reporting showing how the

funds were spent in Veteran. Sam exited at 6:30pm.

DELEGATION Village Foreman joined the meeting with a few possible capital projects for 2012, which

included upgrading the street sweeper and zamboni. Darryl exited a 6:20pm.

COUNCILLORS REPORT:

Mayor Gorcak – the Lions Club have already purchased some grey hall chairs, but it would look better if all the chairs were the same. A quote will be received and brought

forward to the next meeting.

A water meeting and ambulance meeting were attended. The East Central Ambulance Association is requesting all invoices for Fire Department assistance be forwarded within 10 working days so as to be included on the East Central Ambulance Ass. invoice. The arena supervisor will be contacted to advise her that when she is unable to work at

the scheduled time, a replacement needs to be found.

Councillor Allison – attended an NHCAL Interagency meeting today. Jan was also asked

to sit on the newly formed Day Care Society.

RESOLUTION: Mayor Gorcak moved that Councillor Allison be appointed as the Village of

Veteran's representative to the newly formed Day Care Society. CARRIED.

Councillor Lafontaine – the Consort Lodge new completion date is March, 2012. Minutes were provided for the December 20th, 2011 and January 17th, 2012 meetings.

C.A.O. REPORT A report was presented to council regarding the tax arrears list.
