MINUTES OF A REGULAR MEETING OF THE COUNCIL OF THE VILLAGE OF VETERAN, IN THE PROVINCE OF ALBERTA, HELD MONDAY, MAY 13, 2013, IN THE VILLAGE OFFICE.

ORDER:

Mayor Gorcak called the meeting to order at 5:34 p.m.

PRESENT:

Mayor Gorcak, Councillor Zacharias, and C.A.O. Debbie Johnstone.

AGENDA:

Councillor Zacharias moved to adopt the agenda as presented. CARRIED

UNANIMOUSLY.

MINUTES:

Mayor Gorcak moved that the minutes of the regular meeting of council held on April 23, 2013 be approved as presented/amended. CARRIED UNANIMOUSLY.

Councillor Zacharias moved that the minutes of the special meeting of council held on May 7, 2013 be approved as presented/amended. CARRIED UNANIMOUSLY.

OLD BUSINESS:

1) East Central Review Ad - final copy was presented to council as information.

NEW BUSINESS:

1) Bike Roadeo - scheduled for May 21st from 9:00am to 3:40pm.

RESOLUTION:

Mayor Gorcak moved to approve Veteran School's request to block off a portion of Lucknow Street that is in front of the school and the intersection to the north of the school on May 21st from 9:00am to 3:40pm for the Bike Roadeo. CARRIED UNANIMOUSLY.

2) Consort 4H Beef Club - requesting use of the arena for their Achievement Day on May 25th or 26th. Last year we donated the facility.

3) #3 Fairway Place – unsightly property was not cleaned up last fall when letter was sent on September 26th, 2012. Another letter will be sent, giving the owners until June 14, 2013 to clean up their property of debris. If they do not, the Village will remove all the debris and all costs incurred will be billed to the owners. A letter will also be sent to the owners of 114 Wheatbelt Road.

4) Tax Sale Date – needs to be set for 2013. Typically the sale is on the first Wednesday in August, which would be August 7, 2013 at 10am.

RESOLUTION:

Mayor Gorcak moved to set the tax sale date for August 7, 2013, at 10:00am at the Village Office. CARRIED UNANIMOUSLY.

- 6) 106 Waterloo Street unsightly and safety issue. A letter will be sent to the owners of 106 Waterloo Street regarding the unsafe condition of the property.
- 7) FCSS Applications we received 2 applications from the Veteran School. Little Chefs for \$800 and One Book One School program for \$450.
